

## **Town of Platteville Monthly Board Meeting Minutes**

**Monday June 12<sup>th</sup>, 2023**

**(APPROVED)**

### **Town Board Meeting**

The meeting was called to order by Tom Weigel at 6:00 P.M.

Members present: Dan Smith, Tom Weigel, Dave Klar, Nathan Niehaus, and Valerie Martin.

The clerk verified that the open meeting law was met.

The agenda was reviewed. Motion by Smith to approve the agenda as presented, seconded by Martin. Motion carried.

The minutes from the May meeting were reviewed. Motion by Martin to approve the minutes as presented, seconded by Smith. Motion carried.

Klar presented the treasurer's report. Total account balances as of June 1<sup>st</sup> were \$558,499.04. Motion by Martin to approve the treasurer's report, seconded by Smith. Motion carried.

The bills for the month were reviewed, totaling \$43,650.25. Motion by Martin to approve the bills as presented, seconded by Smith. Motion carried.

Fire Chief Ryan Simmons and City Manager Clint Langreck presented updated information about the construction of the new fire station. The project is trying to work on a design with a total project cost of 12.5 million dollars of that cost around \$417,000 would be Platteville Townships portion of the project cost.

No bids were submitted for the walking path resealing project. Niehaus will reach out to contractors to try and obtain some proposals.

Niehaus presented a liquor license renewal for THE BARn, all paperwork was received with a check for the license renewal and server's licenses. Motion by Smith to approve the license renewal and server's licenses, seconded by Martin. Motion carried.

Niehaus stated that Greg Faherty was out of town and hasn't submitted the paperwork for the license renewal and server's licenses for Platteville Golf & Country Club. Faherty stated that he would have the paperwork to Niehaus the following morning. Motion by Smith to approve the license renewal and server's licenses as providing all paperwork and payment was received, seconded by Weigel. Motion carried.

The ATV/UTV Ordinance was discussed. Niehaus is going to check on operation times and dates to make sure the ordinance matches the Grant County Ordinance.

Kurt stated that the North Second landscaping has been completed. He is going to need more cold patch soon, also stated that Fahrner is projected to be here the end of June for sealcoating.

No new driveway or building permits.

Bob Digman stated that Lange's want fence reconstructed on Southwest Road so they can run cattle down the road, he doesn't feel that it should be allowed for them to run the cattle up and down the road. Weigel is going to check into this.

The board placed the checks in envelopes for the bills to be paid.

Motion by Smith to adjourn the meeting, seconded by Martin. Motion carried. The meeting was adjourned at 7:30 P.M.
