

Town of Platteville Monthly Board Meeting Minutes

Monday September 11th,2023

Town Board Meeting

The meeting was called to order by Tom Weigel at 6:00 P.M.

Members present: Dan Smith, Tom Weigel, Dave Klar, Nathan Niehaus, and Valerie Martin.

The clerk verified that the open meeting law was met. Notice was posted in 3 locations, and the website. WWW.TOWNOFPLATTEVILLE.COM

The agenda was reviewed. Motion by Martin to approve the agenda as presented, seconded by Smith. Motion carried.

The minutes from the August meeting were reviewed. Motion by Smith to approve the minutes as presented, seconded by Martin. Motion carried.

Klar presented the treasurer's report. Total account balances as of September 1st were \$423,354.74. Klar asked about renewing the current CD, Weigel asked him to see if Clare Bank would offer a more competitive interest rate on the accounts without the funds being in a CD. Motion by Martin to have the current CD renewed, seconded by Smith. Motion carried. Motion by Martin to approve the treasurer's report, seconded by Smith. Motion carried.

The bills for the month were reviewed, totaling \$6564.99. Motion by Martin to approve the bills as presented, seconded by Smith. Motion carried.

The garbage and recycling contract was tabled until next month. The board asked Niehaus to contact some other business to see if they would be interested in providing the service and check into pricing.

Chief Simmons, and City Manager Langreck were present to discuss the current fire station proposals. Discussion amongst everyone present was that the current site with 7 bays and additional property was the best option for the Town. Motion by Weigel to recommend the City Council Option #3 with the 7th bay, seconded by Smith. Motion carried with Martin apposing.

Weigel stated that Kurt had a knee replacement done a couple weeks ago and is off work, Carol Ann has been checking the roads. He also stated that the seal coating is done and that the blacktop wedging should be finished soon.

No new driveway or building permits.

Weigel stated that the Fox property on Old Lancaster Road in the pasture is being excavated and they do not have any permits, Grant County Zoning is looking into this, he also stated that Barth Eastlick is looking at building a new house and has been told he doesn't have enough access to the property by the zoning office.

Niehaus asked about the MOU with Gerard Abing for a cul-de-sac. Weigel stated that he and Kurt would look at it.

Smith stated that he had a conversation with Jim Lory about a tree being taken down. Weigel stated that he was told to have the tree cut down and the town would pay the bill for the cutting.

The board placed the checks in envelopes for the bills to be paid.

Motion by Smith to adjourn the meeting, seconded by Martin. Motion carried. The meeting was adjourned at 7:56 P.M.
